## Dearborn Table Lamp

## **IMPORTANT SAFETY INSTRUCTIONS:**

- These instructions are provided for your safety. It is very important that they are read carefully and completely before beginning the assembly and installation of this lighting fixture.
- This portable luminaire has a polarized plug (one blade is wider than the other) as a safety feature to reduce the risk of electric shock. This plug will fit in a polarized outlet only one way. If the plug does not fit fully in the outlet, reverse the plug. If it still does not fit, contact a qualified electrician. Never use with an extension cord unless plug can be fully inserted. Do not alter the plug. Do not attempt to defeat this safety feature.
- Making sure light bulb does not touch the shade sides.
- This fixture has been rated for up to two (2) 60-watt maximum TYPE A standard incandescent light bulb (not included) or two (2) 9-watt SBLED light bulb (included). To avoid the risk of fire, do not exceed the recommended lamp wattage.
- Use with approved REJUVENATION Shades only, having a minimum opening diameter of 3-1/2 inches and a minimum lamp-to-shade spacing of 2-1/2 inches.
- This lighting fixture is meant for indoor use.
- Save these instructions.


## WARNING:

- To reduce the risk of fire, electrical shock or personal injury, always turn off and unplug the light fixture and allow it to cool prior to replacing the light bulb.
- Do not touch bulb when fixture is turned on. Do not look directly at lit bulb.
- Keep flammable materials away from lit bulb.


# **PRE-ASSEMBLY:**

- Remove all parts and hardware from box along with any plastic protective packaging.
- Do not discard any contents until after assembly is complete to avoid accidentally discarding small parts or hardware.

Parts Included:	
(A) Finial (1)	
(B) Shade (1)	
(C) Holder (1)	
(D) Socket (2)	
(E) Bulb (2)	



# TO ASSEMBLE:



Unscrew the Final (A) from the top of Holder (C).


Place the Shade (B) over the top of Holder (C). Make sure the top of Holder (C) extends through the center ring of Shade (B).

Secure the Shade (B) by turning the Finial (A) onto the top of Holder(C) until tight.

Insert the specified light bulb(E) into the Socket (D). DO NOT EXCEED THE SPECIFIED WATTAGE.

Plug the power cord into the proper electrical outlet. Turn on/off the lamp by pulling the pull chain (F) or pressing the rocker switch (G) on the back side of base.

The pull chains (F) are removable, if desired.



Note: There is a USB port on the fixture base, which can be used for charging USB devices (USB charging cable is not included.) The output maximum is 5V/2A. Do not overcharge.

## CARE INSTRUCTIONS:

- Wipe clean with a soft, dry cloth or static duster.
- Always avoid the use of harsh chemicals or abrasive cleaners as they may cause damage to the fixture's finishing.
